



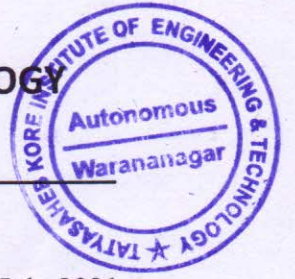





1. Coordinator welcomed all the members and heads of the department. Honorable Principal expresses his views on academic audit.
