Framing the implementation policies for autonomous status of institute

A) Finalization of different autonomous handbooks of the institute

Description: Institute has prepared three handbooks as guideline for the academic, administrative and examination reforms during implementation of autonomy. These handbooks are

- 1) TKIET Handbook-1: Rules, Regulations and Responsibilities (Version 2.0)
- 2) TKIET Handbook-2: A Path to Implement Autonomy (Version 2.0)
- 3) TKIET Handbook-3: Examination Conduction under Autonomy (Version 1.0)

However, the devising of version 2.1 and 1.1 of handbooks are in process for the final implementation under the autonomy status. Hence all HoDs, Deans, faculty and staff were informed to go through the attached handbooks/manuals and provide constructive suggestions on or before Thursday, 31st December 2020 at tkiet.suggestions@tkietwarana.ac.in

Proposed Action: There is need to modify the handbooks after considering the suggestions given by the faculty. The action taken plan is required to be discussed and finalized in the meeting. It should be convey to the handbooks' preparation committee.

B) Preparation of F. Y. B. Tech. and other classes' syllabus structures and monitoring the activities

Description: There is need to prepare the F. Y. B. Tech and other classes Syllabus structure before the 10^{th} January 2021 which will be implemented for the current academic year 2020-21 under autonomy.

At present, the first version of Draft copy of the F. Y. B. Tech. structure is prepared which has credits of 25 each semester. There is suggestion by external expert to modify this draft to reduce the credits of semesters to 21-22. It is essential to offer honor degree in future to the students.

About Honors Degree

'Honors' means a higher recognition awarded to a well performing UG students on earning the specific extra credits after satisfying the relevant degree award conditions (Refer Annexure -2) The objectives of decorating the students with superior academic ability with honors are

- 1. To encourage the advanced levels of study and multidisciplinary learning
- 2. To specialize in a focused area of their interest
- 3. To learn new skills and methodology pertaining to their area of interest
- 4. To enable personal creativity and cultivate a sustaining interest in advanced education and research
- 5. To provide opportunities to gain recognition at the time of graduation for distinguished work

- AICTE has introduced a scheme wherein the each student has to earn 18 or more additional credits during four years program including online courses.
- Registration to Honors qualification shall start from fifth semester onwards and registrants shall have obtained a CGPA \geq 8.50 at the end of the fourth semester.

At present, the prepared syllabus structure has been discussed in the HoDs meeting and Syllabus preparation Committee of first year faculty has been constituted to finalize the draft of F. Y. B. Tech. for autonomy.

Then proposed syllabus will be put forward to the BoS of F.Y. B. Tech and academic Council of the Institute for final approval.

Proposed Action: The monitoring of this process will be done by the IQAC. As per instruction of principal, Dr. D. N. Mane, Head, Dept. of F. Y. B. Tech and Dr. V. D. Patil madam from IQAC will monitor the entire process and will submit the completion report to the IQAC in coming days.

C) Formation of BoS of different departments (3 min)

Description: Already the Boards of Studies of different departments have been prepared. After the autonomy results, it is needful to finalize the members of BoS. All departments should complete the process of formation of BoS and take the written approval from Principal Office. Prepare the standard document of it with consent letters of all members and submit the copy to IQAC and Principal Administrative Office.

Proposed Action: On behalf of IQAC, Prof. S. A. Desai sir will look after the entire process and will collect the document and do needful actions.

D) Initiative to make policy of autonomous examination mode (5 min)

Description: The success of the Autonomous status of the institute is only possible through the quality teaching learning process and Integrity, honesty, reliability of examination/ evaluation process. It is very sensitive area of the entire education process and institute has to take greater care while execution of examination activities under autonomy. It is need to prepare the plan for conduction of examination for F. Y. B. Tech. under autonomy. It must include

Formation of question paper structure, answer book design, registration and enrollment documentation, Formation of subject expert panels, method of exam notifications, preparation of exam schedule, seating arrangement, plan to conduct written exam, assessment and moderation strategy, result declaration are the important activities under this umbrella. It is need to study the mechanism of other colleges and also need to visit the other institute to understand this process.

Proposed Action: Prof. M. B. Kulkarni sir, is appointed as Dean Examination. He is requested to prepare and present this entire plan in front of IQAC and Academic Council in next month. IQAC member, Prof. S. S. Desai sir will take follow up of this presentation and will do needful process

For colleges which have become Autonomous from 2014-15, the NAAC may extend their existing Accreditation Status till they become eligible for applying as an Autonomous College, i.e., 5 years or 2 batches of students. (Refer Annexure –2)

The necessary information is required to take the benefit of the same. The correspondence is required to do with NAAC to know about present status of this NAAC resolution.

Proposed Action: Prof. C. P Shinde Sir and Mr. G. S. Kamble will take the required follow up about this issue and convey the updates to the Principal Office for further action.
