The committee will suggest measures to prevent atrocities, if any, against any of the SC/ST students in the institute and to ensure amongst them as per the provisions in the said Act.

Roles and Responsibilities:

- To counsel and guide SC/ST students and help them to manage academic and personal issue if any.
- To inform the SC/ST students regarding various scholarships/program of State Govt. and UGC.
- Function as a Grievance Redressal Cell for the grievances of SC/ST students and employees of the college and render them necessary help in solving their academic as well as administrative problems.
- To ensure the prevention of Atrocities on the SC, ST Staff, Faculty and Students.
- To hear and Resolve the issues/complaints if any; of such Atrocity reported/complained.

The Composition of SC/ST Committee (as above)

1. The Principal of the College is the Chairperson.
2. One Senior faculty from the college is the Vice-Chairman of the Cell.
3. One ladies' representative from the Teaching Staff.
4. Four representatives from the college, Three from Teaching and One from Non-Teaching Staff.
